ENVIRONMENTAL HEALTH

Body Art Facility Floor Plan Information Sheet

Plans MUST include: floor plan, finish schedule (floors, walls and ceiling materials and/or paint), and all plumbing and associated fixtures must be indicated. The plan does NOT need to be to scale but setbacks and distances, where required, must be clearly indicated. Manufacturer specification sheets (cut sheets) for any autoclaves, sonicators, etc., must be included with plan check package.

FLOORS/ WALLS/CEILING:

_____ Shall be smooth, free of open holes, and washable (brick, concrete block, rough concrete, rough plaster or heavily textured gypsum board are not acceptable).

PROCEDURE AREA:

- _____ Must be separated from the decontamination and sanitation area by at least five feet or by a cleanable barrier.
- _____ Must have a sink dedicated to hand washing, with liquid soap and single service (paper) towels provided in permanently installed dispensers adjacent to each sink. Hot and cold water through a mixing faucet must be provided. Hand wash sinks shall be of a sufficient number and conveniently located for use by all practitioners and may not be used for purposes other than hand washing. One sink may serve many work stations if easily accessible.
- _____ Must be equipped with a light source that provides adequate light at all work stations.
- _____ Must be separated from nail and hair activities by a wall.
- _____ Must be equipped with an approved, properly labeled, sharps container that shall be portable, if portability is necessary to ensure that the container is within arm's reach of the practitioner. The sharps container may be located in the decontamination room if required by best blood borne pathogen practices.

DECONTAMINIATION/SANITATION ROOM:

_____ Must be equipped with a sink, hot and cold running water, liquid soap in a wall mounted dispenser, and single use paper towels dispensed from a wall mounted, touch less dispenser that is readily accessible to the practitioner.

BATHROOM:

_____ Must have a hand wash sink, with hot and cold water provided through a mixing faucet, liquid soap and single service (paper) towels in permanently installed dispensers adjacent to each sink.

_____ Exhaust ventilation must be provided per local building codes

INSECT SCREENING:

_____16 mesh insect screen must be provided on every operable window and any door that remains open.

HOME STUDIOS:

_____ Must be separate from any residential areas used for sleeping, bathing, or meal preparation. A body art facility associated with a residential dwelling shall have a separate entrance and toilet facility, and shall not have a door allowing direct access between the body art facility and the residential dwelling.
